Trust Amendments made in Finance Act, 2023 and Compliance

1. Application out of corpus or loans or borrowings:

Income not allowed as application shall be treated as application only if there was no violation of the conditions, specified in clause (c) of, and Explanations 2, 3 and 5 of, sub-section (1) and Explanation to section 11 of the Act and clause (c) of sub-section (1) of section 13 of the Act, at the time the application was made from the corpus or loan or borrowing.

Recoupment of corpus fund/repayment of loan to be regarded as application only if recouped/repaid within **5 years** from the end of year in which such funds were utilized from such corpus/loan.

nothing contained in first proviso shall apply where application from corpus or loan or borrowing is made on or before the 31st day of March, 2021.

Further, amount utilized out of such corpus shall meet the following criteria in order to claim the Recoupment of corpus to be claimed as application of Income:

- 1. There should not be a **corpus donation** to another trust.
- 2. Should have complied with the TDS provisions
- 3. There should not be any cash payment in a day to a person for> Rs. 10,000
- 4. Carry forward and set off of excess application is not allowed.
- 5. The amount utilized is only allowed in the year which it is **actually paid**.
- 6. There should not be any direct or indirect benefit to any **person** referred to in **Section 13(1)** of the Act.

2. Accreted Income U/S. 115TD even for failed to apply for Re-Registration:

If Trusts/Institutions shall register/ re-register U/s 12AB within the specified time. If ant Trusts/Institutions fails to re-register U/s 12AB shall be deemed to converted into Non-charitable Organization.

Then the Trust/Institutions shall be liable to pay tax on accreted income within 14 days from the end of previous year.

INTRODUCTION

Foreign Contribution (Regulation) Act, 2010 came on the statute book on 1st May 2011, by replacing earlier Act of 1976. After the introduction of the Prevention of Money Laundering Act, 2002, it was felt that FCRA, 1976 needs complete change and did not serve any meaningful purpose. The Government of India thereafter introduced the Foreign Contribution (Regulation) Amendment Bill, 2020 that ("FCRA Bill") which received the assent of the President on September 28, 2020, notifying the effectiveness of the Foreign Contribution Regulation Amendment Act, 2020 ("FCRA Amendment Act") from September 29, 2020.

The FCRA is administered and regulated under the Ministry of Home Affairs, Government of India, through only one office at New Delhi. There are no branch offices anywhere in India.

The basic purpose of FCRA 2010 is "to consolidate the law to regulate the acceptance and utilisation of foreign contribution or foreign hospitality by certain individuals or associations or companies and to prohibit acceptance and utilisation of foreign contribution or foreign hospitality for any activities detrimental to the national interest and for matters connected therewith or incidental thereto."

Applicability

This Act extends to whole of India and is applicable to the organisations having a definite cultural, economic, educational, religious, or social program and persons in sensitive government positions, political parties and persons associated with the news media.

As such the provisions of FCRA, 2010 can be broadly classified in the following three categories:

- 1. Prohibition on certain persons from accepting foreign contribution.
- 2. Restriction on certain persons from accepting foreign hospitality.
- 3. Regulating the acceptance of foreign contribution by persons having a definite cultural, economic, educational, religious, or social program. Charitable Trusts and NGOs are covered under this category.

All permission, registrations, procedures, mandatory filing are required to be done by logging in https://fcraonline.nic.in The organizations take their login id and password while applying for registration under the Act.
